

### ASSIGNMENT OF A TERM - 8 September 1767

### **Descriptions**

# **Recitals**

"" Whereas by Indenture of Mortgage bearing date the fourth day of June One thousand

seven hundred and forty two and made or mentioned to be made between Samuel Cowndley of Cleobury Aforesaid Taylor of the one part

Elizabeth Millner then of the parish of Neen Savage in the said County of Salop Spinster of the other part The said Samuel

Cowndley for and in Consideration of the sum of forty pounds of Good and Lawful English money to him by the said Elizabeth

Millner **Did** Demise Grant Sett and to Farm Lett unto the said Elizabeth Millner her Ex[ecu]tors Adm[inistrat]ors and Assigns **All** that his new erected

Messuage or Tenement and all that his piece or parcell of Meadow Ground Called or known by the Name of the Sling Situate lying and being in the parish

of Cleobury Mortimer aforesaid lying to the Lands of Sir Edward Blount Barronet on the East side and Lands of William Bradley Gentleman on the North

and West Sides thereof And Adjoining to the Kings Highway on the South part thereof together with all Ways Waters Watercourses Easements



Proffitts Commons and Appurtenances whatsoever to the said Messuage or Tenement Land and premisses belonging or in any wise appurtaining **To hold** 

the same unto the said Elizabeth Millner her Ex[ecu]tors Adm[inistrat]ors and Assigns from the date of the said Recited Indenture for and during the full End and

term of Nine hundred and Ninety Nine Years from thenceforth next Ensuing and fully to be Compleat and Ended at and under the yearly Rent of A

Pepper Corn Payable as therein mentioned and in which said recited Indenture is Contained A Proviso that if the said Samuel Cowndley his Ex[ecu]tors Adm[inistrat]ors

and Assigns /should pay unto the said Elizabeth Millner her Ex[ecu]tors Adm[inistrat]ors and Assigns/ the Full Sum of Forty pounds Together with the Sum of Twenty Shillings as Interest for the same on the Fourteenth day of December then next Ensuing That then the same should Cease and be void as in and by the said in part recited Indenture relation being had thereunto more Fully

and at large appear **And Whereas** by one other Indenture of Assignment Tripartite bearing date the twenty sixth Day of September One thousand seven

hundred and Forty seven and made between John Bate of the parish of Bitterley in the County of Salop aforesaid and Elizabeth his wife | late Elizabeth Millner

party to the aforesaid recited Indenture | of the first part The said Samuel Cowndley of the second part and the said Francis Page | Father of the said Francis

Page party hereto | of the third part the said John Bate and Elizabeth his wife for and in consideration of the Sum of Forty pounds to them in hand paid

all interest for the same then being fully paid and Satisfied by the said Samuel Cowndley Did by and with the Consent Direction and appointment

of the said Samuel Cowndley Grant Assign and Set over unto the said Francis Page his Ex[ecu]tors Adm[inistrat]ors and Assigns All and singular the

said Messuage or Tenement Lands and premisses in and by the said Recited Indenture to be granted and Demised as Aforesaid and the Reversion and Reversions Remainder and Remainders Rents Issues and Proffitts thereof and every part thereof **To hold** the same

unto the said Francis Page his Ex[ecu]tors Adm[inistrat]ors and Assigns from the date of the said Indenture for and during all the rest residue and remainder of

the said Term of Nine hundred and Ninety Nine years which was then to come and unsatisfied Asolutely Discharged of the said Proviso

But Subject to another Provisoe mentioned in the said last in part recited Indenture that if the said Samuel Cowndley his Ex[ecu]tors Adm[inistrat]ors

or Assigns should pay unto the said Francis Page his Ex[ecu]tors Adm[inistrat]ors and Assigns the sum of Forty one pounds of lawful English Money upon the

Twenty Sixth Day of March then next Ensuing without Deduction that then he the said Francis Page his Ex[ecu]tors Adm[inistrat]ors and Assigns should at

the Request Costs and Charges of the said Samuel Cowndley his Heirs and Assigns Reconvey and Assign the said Premisses herein before mentioned

to be Mortgaged and Assigned to him the said Francis Page to such person or persons as the said Samuel Cowndley his Heirs and Assigns should

Direct free from all Incumbrances whatsoever **And Whereas** the said Samuel Cowndley is lately Dead And the said Mary Colebatch hath since purchased

the Fee simple and Inheritance of the said Premisses herein before mentioned of and from the heirs at Law of he the said Samuel Cowndley Subject

to the aforesaid Assignment of Mortgage to the said Francis Page and she the said Mary Colebatch being desirous of paying off and discharging the

said Mortgage and that the said Estate may be Clear of all Incumbrances she the said Mary Colebatch hath this Day paid off and Discharged to the said

Francis Page | party hereto | as Acting Ex[ecu]tor of his late Father as aforesaid | the Sum of Forty Pounds for the Principal of the aforesaid recited Mortgage and

Five Pounds Interest thereon due to this Day And the Fee Simple of the said Premisses being in the said Mary Colebatch the term & Estate

now vested in the said Francis Page | Party hereto | is hereby intended to be Forthwith Assigned & Transferred to the said Thomas Colebatch his Ex[ecu]tors

may Be Prescribed and kept on Foot to attend and wait upon the Revertion and Inheritance of the said Premisses to Protect and Defend the Same from all

Incumbrances subsequent to the Creation of the said recited term
