The condition of this Obligation is such That if the above bounden *Timothy Ball his* Heirs Executors Administrators *any or either of them* shall and do well and truly pay or cause to be paid unto the above named *John Fox his* Executors Administrators or Assigns the Full sum of *Sixty Pounds* of good and lawfull money of Great Britain *with lawfull Interest for the same at and upon the thwentieth Daof March now next ensuing this Date hereof without any Deduction and* without Fraud or further delay Then this Obligation to be void and of none effect or else to remain in full force and virtue
